- Return the results of education and research to the city and its residents to contribute to the development
 of the local community and global society.
- o Be a university that is beloved by the residents of Osaka.
- · Carry on the traditions and culture of the city of Osaka as an urban university.
- · Promote free and creative education and research, as well as high quality medical care.
- Work together with residents to improve the various functions of the city, including culture, economy, industry, and medicine, with the aim of realizing true wealth.

Basic Policy on Education

- Stand on the principles of a university for the residents, with the city of Osaka in the background
- Contribute to the happiness and development of humanity
- Fulfill the role of a guiding force in various fields, and cultivate human resources who can succeed in society

Basic Policy on Research

- Promote original and distinctive research with the goal of creating new knowledge
- Tackle various challenges faced by the city, return the results to city and its residents, and contribute to the development of the local community
- o Promote research that will lead to the creation of new industries, and return the results to society

Goals for Human Resource Development

Develop human resources who can systematically study research results in their respective academic fields, and who have the creative ability to apply develop these to interdisciplinary fields.

<The Three Policies of the Osaka City University Graduate School Courses>

[Distinctions and Goals of Education at Osaka City University]

Osaka City University (OCU) traces its beginnings to the 1880 founding of Osaka Commercial Training Institute. It was later renamed as Osaka City Commercial College, launched as the first municipal university in Japan, and continues today as a public university with a long history and tradition. It is one of the few comprehensive public universities, making progress as a research university on a foundation of high level, diverse academic research. Simultaneously, the university has cultivated people responsible for the development of Osaka and the future of Japan and the world, with an "academic culture that emphasizes the organic connection of theory and reality" and a respect for independent and enterprising character rooted in the spirit of the city.

As a university that practices these traditions while encompassing diverse academic fields including 8 undergraduate faculties and 10 graduate schools, OCU makes use of its status as a place for various types of international and unique research, while conducting education in small classes with sophisticated, openminded students. OCU aims to always cultivate the next generation of people who will learn to judge the value of truth, goodness, and beauty, develop a sense of wisdom and civic duty, and collaborate with diverse parties while fulfilling a leadership role in many fields in their community and society, in order to contribute to the harmony and development of Osaka, Japan, and the world as a whole, which now face many diverse challenges.

[Diploma Policy]

Osaka City University, through its graduate school education, cultivates students who can contribute to society and researchers and professionals who will advance their expertise, develop broad knowledge, and fuse these together.

In order to achieve this goal, OCU awards degrees to students who master advanced knowledge and skills related to their field of expertise established in their graduate school, follow research guidance in line with the principles and purpose of the education and research of their graduate school, earn a certain number of units during a certain period of enrollment, and pass examinations and tests.

In the doctoral courses, the standard for completion of the course is whether or not the doctoral candidate has developed the necessary abilities and learned the foundational knowledge in order to become an independent researcher that can pioneer new research areas and act globally, and become specialists with a particularly high level of knowledge, technical skills, and research abilities.

[Curriculum Policy]

Osaka City University, in order to achieve the study results stated in our diploma policy, has systematically composed an educational program consisting of classes on the department fields of each graduate school, graduate school general education classes provided to the entire university regardless of graduate school, and doctoral program education leading program classes prepared separately from the main departments. The university also holds classes in diverse formats including lectures, seminars, and practical training, to conduct research guidance in line with the principles and purposes of the education and research of each graduate school.

Graduate school general education classes are established with the purpose of students developing the right attitude to do research from a universal and fair perspective beyond their expertise, which is necessary for achieving educational and research goals through the graduate school curriculum.

[Admission Policy]

Osaka City University, through its graduate school education, in order to cultivate students who obtain the results of study stated in the university's diploma policy and achieve educational goals, accepts students both from Japan and abroad who have solid fundamental academic abilities and adequate knowledge in their field of expertise gained through study in undergraduate and graduate educational programs, who have a rich humanitarian spirit, and the will to contribute to the development of industry, culture, lifestyle, and environment in science and cities, as well as a strong sense of curiosity.

In order to fairly select such students, the university implements various selection methods for each recruitment unit of graduate schools and their departments.

2. Applicant Qualifications

Applicants must not have Japanese nationality and meet one of the following criteria.

- ① Have received or expect to receive by March 2018 a master's degree or a degree equivalent to a professional degree outside of Japan.
- ② Have received or expect to receive by March 2018 a master's degree or a professional degree at a graduate school in Japan as an international student.
- ③ Have received or expect to receive by March 2018 a master's degree or a degree equivalent to a professional degree through correspondence course provided in Japan by a foreign school of said country.
- ④ Have completed or expect to complete the curriculum of an educational facility in Japan which is positioned in the academic educational system of a foreign country as having the curriculum of a university of that foreign country and has been specially designated by the Minister of MEXT (the Ministry of Education, Culture, Sports, Science and Technology of the Japanese Government) by March 2018 a master's degree or a degree equivalent to a professional degree.
- (5) Have completed a course at the United Nations University and have received or expect to receive by March 2018 a degree equivalent to a master's degree.
- (6) Have completed an educational course at a foreign school, educational institute which has the designation of applicant qualification (4) or the United Nations University and have passed the examinations or something equivalent to a screening regulated by the provisions of Article 16, Paragraph 2 of the Standards for Establishment of Graduate Schools and were approved in the said graduate school to possess a degree equivalent to a master's degree.
- (7) Be designated by the Minister of Education through 1989 Public Notice of the Ministry of Education No. 118.
- 8 Be acknowledged by an individual Admission Qualifications review in the applicable graduate school as having academic ability equal to or greater than a master's degree or a professional degree holder, and be 24 years or older as of March 31st, 2018.

Notes:

- 1.) In the Graduate School of Business and the Graduate School of Economics, the master's degrees referred to in "2. Applicant Qualifications" part (1) to (6) are master's degrees in management, commerce, global business, economics, urban business, urban policy and urban informatics.
- 2.) In the Graduate School of Law, master's degrees referred to in "2. Applicant Qualifications" part (1) and (6) are master's degrees in law and political science.
- 3.) In the Graduate Schools of Business, Economics, and Law, applicants who hold other master's degrees besides Notes 1)-2), or professional degrees or are attempting to apply by the criteria of "2. Applicant Qualifications" part (6) to (8) must submit an "Application Qualifications Review Application Form". Contact the administrative office of each graduate school at the Student Support Center in advance, and submit the necessary documents to the office of each graduate school at the Student Support Center by Thursday, November 29, 2018. (See "Application Qualifications Reviews" on page 19). For the Graduate School of Business, in addition to Note 1 above, applicants besides those who acquired master's degrees designated in Note 1) by submitting master's thesis must submit an "Application Qualifications Review Application Form" in order to have their Application Qualifications certified. Consult with the Office of the Graduate School of Business by Thursday, November 29th, 2018.
- 4.) Applicants who wish to take exams in "2. Applicant Qualifications" (1), (3) and (5) for the Graduate School of Business should make inquiries to the office of the Graduate School of Business by Thursday, November 29, 2018.
- 5.) "Applicants designated by the Minister of Education through 1989 Public Notice of the Ministry of Education No. 118" means those who have graduated from a university or those who engaged in research at a university or a research institute, etc. more than two years after having completed 16 years of school education in a foreign country and those who have been recognized as having academic ability equal to or greater than a master's degree by the results of said research in the said graduate school.

3. Advance Consultation

Aspiring applicants must have their Application Qualifications and desired academic supervisor confirmed. Before applying, consult with the research supervisor by Thursday, November 29th, 2018. The application may not be approved without advance consultation.

Contact the administrative office of each graduate school at the Student Support Center for the contact information of academic supervisors (The telephone numbers of the administrative office of each graduate school are on the back cover). 5. Submitting of Applications

Applicants must pay the application fee, prepare the application documents, and use the application envelope designated by Osaka City University (If not all application documents fit in the envelope, then they may be sent in an envelope with the front of the application envelope designated by Osaka City University attached to the front) to send their application documents to the following address by **registered express mail or EMS**.

However, applicants enrolled in Osaka City University (including research students and trainees) may submit their application documents directly to the administrative office of each graduate school in the Student Support Center from 10:00 to 17:00 during the application period (Except 12:00 – 12:45). (Use the application envelope designated by Osaka City University.)

(Applicants may be asked to submit the school regulations and syllabuses or equivalent documents from their most recently graduated school.)

3.) Documents displaying work experience or academic ability (Submission may be requested)

4.) Statement of motivation

(Submission may be requested)

5.) In addition, per the desire of the applicant, Osaka City University will permit the attachment of other certificates, essays, works, or other materials.

For documents written in languages other than Japanese or English, the applicant must also submit a translation certified by an official institution (such as the applicant's university, Japanese language school, or embassy).

(Certificates that require translations do not need to be in a sealed envelope.)

*Submitted documents in principle will not be returned.

- 4. Applicant Qualifications Review: According to the selection methods of each graduate school.
- 5. Applicant Qualifications Review Results Notification: Notifications will be made by mail (express delivery) at least one week in advance of the application deadline.

(However, the Graduate School of Science will contact applicants separately.)


